



THE ORGANIZATIONAL WORLD

by E.S. TEW

In his recently published book entitled " Beyond the Welfare State " Gunnar Myrdal analyzes what he calls the " organizational State ". He points out that the whole character of our national communities is changing :

" What in reality — constitutional forms aside — constitutes public policy is now

decided upon and executed in many different sectors and on different levels : not only directly by the central state authorities and by provincial and municipal authorities, which in this process are taking over more and more responsibilities, but also increasingly by a whole array of " private "

power groups, organized to promote group interests and common causes ... To the measures of state intervention we must now add those taken, not only by the provincial and municipal authorities which are within the formal structure of the slate, but also by all the other organizations outside this structure ... They hold more and more real power in their fields of activity. Even the regulatory coordination undertaken by the state authorities is ordinarily carried out only after consultation and actually in cooperation with the organizations.

" In the advanced Welfare State, the increasing strength, number and activity of

these organizations... has meant a spreading out of participation, initiative and influence over what is, in reality, legislation and administration to ever larger sections of the people themselves in their various localities and operations. It represents a decentralization of the making and implementation of public policies... Individual citizens increasingly participate in the collective instruments of public policy beneath the state level."

Similar infiltration into matters of public welfare has already occurred on a world-wide scale to an extent which does not seem to be appreciated by the political practitioners or

theorists. In the 1,200 currently active international non-governmental organizations private individuals from all over the world are amicably regulating on an international basis every conceivable field of interest to mankind. It would of course, need a social scientist of the calibre of Professor Myrdal to evaluate precisely and systematically the sociological, economic and political implications of all this trans-frontier activity. But a start can be

made by presenting a few of the facts that can be gleaned from the new edition of the "Yearbook of International Organizations" (1).

From Table I it can be deduced that the structural framework of international coopera-

tion, practically non-existent in 1840, became fully grown by 1950. Up to that time the annual rate of increase in the number international organizations had been rising faster and faster. Less than three a year were founded during the period 1880-1900; seven a year between 1901 and 1920; 14 a year between 1921 and 1940; 37 a year between 1941 and 1950; reaching a peak of 60 a year in the early fifties. Since then the rate has remained steady. In fact, the annual number of new international non-governmental bodies has shown a slight tendency to decline. The reduction

would have been even more marked if the activities of the European Communities had not led to a remarkable efflorescence of new groupings in the commercial and industrial sector. Of the 1409 existing international organizations 513 were founded before World War II, and a further 667 between 1941 and 1955. Longevity, by the way, seems to be a characteristic of associations working in the religious sector. Mortality, on the other hand, can be studied by comparing the figures given in Table I with those shown in Table II of "The 1,978 International Organizations founded since the Con-

gress of Vienna" (2). The latter includes not merely the currently existing organizations but also those which have fallen by the wayside.

Who runs them ?

Table II shows that there are now at least 34,694 individuals directly concerned with the running of international organizations. (The corresponding figure in 1958 was 34,087 (3)). To the total must be added the staff of 48 organizations which employ an unspecified

number of voluntary workers, plus the statistically unmanageable "3 semi-voluntary staff" of one of the oldest established organizations in the agricultural field.

The contrast between governmental and non-governmental international organizations emerges very clearly as regards staff. Whereas the average number of employees per inter-governmental organization is 77, all of whom are paid, the average for non-governmental organizations is 12, of whom over one-third are unpaid.

Their money

The division between rich and poor is evident. Not merely as between governmental

(average income \$ 5,928,000, a 31 % increase since 1958) and non-governmental (average income \$ 587,621, a 3 % decrease since 1958) but between the latter themselves, for whereas there are two which each handle more than \$ 110,000,000 a year, there are eleven which manage to get along happily on \$ 200 or less each. (Table III).

Their congresses

If the variation as regards financial status is almost infinite the variation in habits as regards meetings is still considerable. Table IV shows that 516 organizations hold an important meeting every year, whereas some never do so, apparently on principle. Fre-

quency is relatively highest among the commercial and industrial organizations and lowest among the medical. Keeping track of their congresses is a complicated process : perhaps it would be simplified if all organizations adopted the practice of a professional body headquartered in the United States, which always has its annual convention on the Saturday following the third Monday in August.

On the other hand the compilation of statistics would be made rather more difficult if many organization were to adopt the formula used by one member of the "awkward squad", namely two congresses every five years. Three other organizations cause statistical difficulties by meeting "normally every 18 months".

Of 1,076 international non-governmental organizations 79 % use English, 77 % use French, 36 % use German and 20 % use Spanish. ORGANIZATION AND METHOD

THE ASSEMBLY OF CAPTIVE EUROPEAN NATIONS

Origin

On September 20, 1954 representatives of nine nations of Central and Eastern Europe met at the Carnegie International Center, across from the United Nations in New York City, and created the Assembly of Captive European Nations. In attendance were political refugees who had escaped from behind the Iron Curtain — from the Soviet-dominated Albania, Bulgaria, Czechoslovakia, Estonia, Hungary, Latvia, Lithuania, Poland, and Romania.

Purposes

Since the Assembly of Captive European Nations (hereafter referred to as " ACEN ") is frankly engaged in efforts to influence public opinion, both in the United States and in the rest of the world, it is of importance initially to establish its overall "goals and purposes.

ACEN publications describe the organization as " designed to serve as a forum in which the aims and views of the enslaved European nations could be voiced, and as an organization within which the efforts of the legitimate representatives of these nations — representing all democratic political trends and groups — could be united on a continuous and enduring basis ".

The aim of the organization, according to its leaders, is to work toward the restoration of free elections in Central and Eastern Europe,


not the restoration of any particular class or regime.

Organization

The ACEN is organized similar to the United Nations. It is composed of national committees of nine nations which are " unrepresented or misrepresented " in the U.N. Each member nation has a 16-man delegation to the Assembly and decisions are made by two-thirds vote. Five groups have 4-man non-voting delegations : The Christian Democratic Union, The International Peasant Union, The Liberal Democratic Union, The Socialist Union of Central and Eastern Europe, and The International Center of Free Trade Unions in Exile. Other international organizations have consultative status with the Social, Legal, and Economic Committees of the Assembly.

There are volunteer ACEN " delegations " in approximately 15 nations where Eastern European exiles live, including Western Europe, Lebanon, Japan, Latin America. There are offices of ACEN in New York, (Headquarters at 29 West 57th Street), London, Paris, Bonn, and one will be opened soon in Buenos Aires.

The former political, religious, and economic leaders of the member nations, who now operate ACEN, claim to represent 100 million captive peoples. The General Committee and various special committees (including the Information Committee) are in continuous session. Day to day administration is in the

hands of a Secretariat, headed by the Secretary-General.

Relations with other organizations

ACEN, primarily because of limited means, does not make a major effort to influence public opinion directly. It works, instead, through contacts with "key people" who are in turn opinion molders or policy makers, and through numerous national and international organizations.

The governments of the free world, outside the United States, are reached primarily through their embassies in Washington and their delegations in the U.N. All documents and publications of the ACEN are delivered to the Secretary-General and President of the General Assembly of the U.N. Also, materials are released to the various U.N. Commissions and Committees. ACEN representatives address organizations formally and contact delegates individually and directly.

It is of paramount importance, of course, for the ACEN to get its viewpoints before that most important of world forums: the United Nations. The location of ACEN House directly

across the street from U.N. Headquarters in New York and the monthly posting of huge signs on the facade of that building to direct the U.N.'s attention to the ACEN viewpoint can be taken as symbolic of this importance.

ACEN also maintains close contacts with other world groups, notably NATO, which recently adopted a resolution on Eastern Europe, and the Council of Europe, which by resolution gives "status" to ACEN. The Consultative Assembly of the Council of Europe includes a "Committee on Non-Represented Nations" and adopted this past fall a "Recommendation on the Present Situation in Eastern and Central Europe", including a statement that "no settlement of the European problem should be regarded as definitive before the peoples of Eastern-Central Europe have had the opportunity to decide about their future by means of free elections". This is virtually a statement of ACEN policy.

Especially close cooperation is maintained with the American Friends of Captive Nations and with the Conference of Americans of Central Eastern European Descent. Also significant is the close collaboration with the American labor movement.

Reaching the public

In attempting to reach the mass of American public opinion ACEN relies primarily on newspaper reports. Between September, 1958 and September, 1959 the Information Committee of the ACEN held 12 meetings. Among the subjects discussed were : popularization of ACEN, Soviet propaganda methods, the programs of the Voice of America, and of Radio Free Europe, and the information media of the West.

Most public information activities, however, are conducted by the Secretariat, through a Press Office, which was established in March, 1955. This office, under the direction of Mr. Vajda, also supplies Radio Free Europe and Voice of America with material for broadcasts and is responsible for supplying the Secretariat with pertinent press material. On special occasions temporary press offices are set up for cooperative activity. For example, the special session of ACEN in Strasbourg in April, 1956 received wide press coverage through this method. A " sampling " of press coverage on the Strasbourg session shows extensive coverage by newspapers in Paris, the French provincial press (particularly Alsatian, of course), the Swiss press, and the Belgian, Dutch, German, and Scandinavian presses.

ACEN News, with a monthly circulation of 10,000, often carries reports on U.S. press coverage. For example, issue # 52-54 (July-September, 1959) carried 7 pages, including reproductions of clippings, editorials, and cartoons from the American and foreign press marking Captive Nations Week;

1958 saw the first reprinting of several editorials from *ACEN News* in American newspapers. Press coverage continues to grow annually. During 1958-'59, a period in which ACEN issued 75 press releases, the picture of the ACEN Human Rights Day poster on ACEN House and comments on Captive Nations Week received the widest circulation in the American press. Evaluation of press coverage is still done primarily " by ear ", with appraisal of propaganda and information efforts in Eastern Europe itself done by interviews conducted with refugees from Eastern Europe and returning visitors to Eastern Europe from the West.

Still another device frequently employed is that of having members of ACEN make formal

speeches before various groups. For example, on July 1, 1959 the Chairman of the ACEN addressed the Annual Freedom Day celebration at the Statue of Liberty in New York City and on July 16 ACEN Secretary General Brutus Coste spoke before 800 reserve officers of the National Strategy Seminar of the National War College in Washington. ACEN delegates have spoken at numerous international congresses, academic institutions, and at seminars on international policy.

Special projects

There are a variety of other enterprises of the Assembly which are difficult to categorize, but which have considerable impact on public opinion. Visual projects and sponsorship of special celebrations will be used to illustrate.

In addition to the considerable quantity of printed materials already referred to, the ACEN has had continual success with " visual aids ". Three color maps were published in 1958 and distributed in parliamentary and academic circles. The following subjects were depicted; " Imperial Russian Expansion in Europe — Soviet Expansion in Europe ", " Imperial Russian Expansion in Asia — Soviet Russian Expansion in Asia ", and " Decline of the Old and Expansion of the New Colonialism Since 1939 ".

A poster display consisting of 40 large captioned panels was exhibited for the first time in Grand Central Terminal, New York City, on January 20, 1958.

Conclusions

How effective is the Assembly of Captive European Nations as a molder of public opinion ? Viewed within the framework of its professed aims, ACEN seems to have been as successful as could have been expected, considering world political developments.

In a special sense, the effectiveness of the particular propaganda devices employed by the ACEN are difficult to evaluate. As has been pointed out, the organization itself has lacked funds to have this type of appraisal done, but the scope and sheer quantity of the activities and efforts of the organization are certainly impressive, and world press coverage, while sporadic, has been extensive. The Secretariat and professional staff appear to be doing an impressive job.

MÉTHODES ET EXPÉRIENCES

Le Centre International de Documentation Muséographique

Le centre de Documentation Muséographique Unesco/Icom (Conseil International des Musées) a été institué en 1948 à la Division des Musées et Monuments historiques de l'Unesco. Il a pour tâche de rassembler et de mettre en valeur pour les muséographes du monde entier le matériel documentaire indispensable à leurs travaux. Muséologues, éducateurs, chercheurs et techniciens des différentes disciplines en relation avec les musées s'adressent continuellement à ce centre.

Le Centre reçoit et organise la documentation muséographique adressée tant à l'Unesco qu'au Secrétariat de l'Icom par les musées et collectivités de musées des divers pays, par des particuliers et par des organismes culturels et commerciaux.

Les documents sont portés à la connaissance de la Division des Musées de l'Unesco et du Secrétariat de l'Icom.

Arrivés au Centre, ils sont *enregistrés* (Catalogue pour les périodiques, fiches de séries pour les catalogues d'expositions temporaires, registres d'entrée pour les monographies et les photographies).


Les documents sont ensuite examinés pour la rédaction des *Nouvelles de l'Icom, Icom News* (analyse des articles ou élaboration de notices bibliographiques). Indépendamment des documents de toutes catégories, 100 périodiques sont régulièrement consultés pour la rédaction des Nouvelles de l'Icom.

Après avoir reçu leur *cote de placement*, sous forme de l'indice de classification repré-

6. *Documentation iconographique* : plans, dessins et croquis, affiches, etc...

sentant le sujet principal du document, les documents font, le cas échéant l'objet d'une analyse précise. Cette analyse est consignée sur des *fiches de dépouillement SYNOPTIC*, selon le système élaboré par M. LAMPEL et M^{me} ODDON. Chaque fiche de format 295 X 240 mm, représente un sujet muséographique et peut recevoir l'indication de 55 documents différents (signalés au moyen de leur cote, date, numéro d'enregistrement et indication en bref des noms d'auteurs ou de musées) et l'analyse, selon le code de classification, de tous les points de vue auquel le document peut être considéré ou recherché.

A l'aide de ces 700 fiches, il est possible de retrouver presque instantanément et avec un minimum de préparation et par conséquent de frais, la documentation (photographies incluses) concernant plus d'un millier de questions d'intérêt muséographique. La juxtaposition de plusieurs fiches permet en outre de multiplier le nombre des recherches.

Classification

La base de classement des documents du centre est géographique, les musées étant répertoriés sous chaque pays dans la langue d'origine, selon les noms de villes où ils sont situés.

Ce classement s'inscrit dans le cadre d'une classification systématique développée depuis la classe AM (Musées) de la Library of Congress (2).

Répertoire international des musées.

Le Centre a été chargé de l'élaboration d'un *répertoire international des musées*. En effet, si certains pays ont publié, parfois à l'instigation de l'ICOM et sur ses conseils, des annuaires généraux ou partiels de leurs musées, il n'en reste pas moins qu'un répertoire international est devenu pour les muséographes un instrument de travail nécessaire. Il permet d'effectuer les recherches tant au point de vue méthodique qu'au point de vue géographique. Il est établi sur fiches SYNOPTIC 150 X 100 mm dont le code correspond à certains critères indexés au plan de classification : catégories administratives du musée, son domaine scientifique, ses collections les plus importantes, ses activités spéciales (services éducatifs, techniques, etc...), ses relations avec l'ICOM et certaines caractéristiques de ses bâtiments.

La diffusion de la Documentation du Centre dépend tout d'abord de deux périodiques : *Muséum* et *Nouvelles de l'Icom/Icom News*, tout comme en dépend dans une large mesure l'accroissement de ses collections, *Icom News*, organe d'information de l'ICOM est en outre la seule publication donnant régulièrement, à l'échelon international, un tableau des activités des musées. Sa chronique est conçue en plein accord avec la rédaction de *Muséum*. Les deux publications se complètent, comme le faisaient autrefois les organes de l'Office International des Musées : « *Mouseion* » et « *Musées et Monuments* » (Informations mensuelles).

Chaque fascicule d'Icom News donne une liste par pays et par catégories de documents reçus au Centre. D'autre part, sous sa rubrique « Informations régionales », la revue donne pour chaque pays, le dépouillement de ses principales publications muséographiques, soit sous forme de sommaires, soit sous forme de comptes rendus analytiques substantiels. Cette rubrique donne également des nouvelles des musées provenant d'autres sources : livres, articles de presse, documents multigraphiés, informations orales, etc...

Dossiers techniques

La plupart des demandes d'information provenant de services de musées, concernent des questions de muséologie actuellement à l'étude. Par exemple la modernisation d'une installation de musée dans un édifice ancien pose de nombreux problèmes que des muséographes ont su résoudre de la manière la plus ingénueuse : il est important que le centre groupe les résultats de ces expériences dans un dossier comportant photographies, plans, textes, etc... De tels dossiers devront être mis beaucoup plus largement à la disposition des spécialistes, dès qu'il sera possible au Centre d'en faire la duplication.

Consultation sur place

Indépendamment des renseignements fournis par correspondance — et qui vont jusqu'à la constitution de dossiers de recherches, le Centre offre aux spécialistes et aux étudiants la possibilité de consulter sur place tous ses documents.

L'Icom figure au nombre des correspondants de presque tous les musées de quelqu'importance, mais il est tout aussi précieux pour le centre de recevoir des nouvelles des petits musées provinciaux ou locaux et de ceux des pays lointains. Leurs problèmes souvent similaires peuvent être plus facilement résolus s'ils sont exposés dans notre chronique et portés ainsi à la connaissance d'autres spécialistes.

Le nombre des comptes rendus de la revue est malheureusement limité pour des raisons budgétaires et il est bien évident que ni les acquisitions même exceptionnelles des musées, ni toutes leurs expositions permanentes ou temporaires, ne peuvent faire l'objet de comptes rendus. Par contre, les références bibliographiques donnent autant que possible le relevé exact et complet de tous les catalogues, guides ou manuels reçus. Les titres ne sont défectueux, la pagination, le nombre d'illustrations et de planches, bu les datés ne manquent, qu'autant que le tolèrent les éditeurs de ces ouvrages.

Si, pour l'élaboration du répertoire international il est indispensable d'avoir dans la langue originale le nom du musée et son adresse, le Centre de Documentation est particulièrement reconnaissant aux muséologues étrangers et aux éditeurs de revues spécialisées en langues néerlandaise, Scandinave, slave, orientales, etc... qui veulent bien compléter leurs articles par un court résumé en langue française ou anglaise : maintes sources d'erreurs se trouvent ainsi écartées.

La Plume au Vent

D'habitude, à l'intention des personnes centenaires, on organise des cérémonies ou des fêtes fort touchantes. Malheureusement, celles-ci ont parfois le fâcheux effet de mettre fin à leur existence.


Pour une centenaire déterminée, la situation est toute différente. Pas de cérémonies, mais une utilisation à outrance et, à présent, des études qui lui gardent et même lui redonnent une jeunesse nouvelle.

A vrai dire, il ne s'agit pas d'une personne physique mais d'une personne morale : la réunion internationale.

On lui prête aujourd'hui une attention plus grande qu'à aucun autre moment de son passé séculaire. Les gouvernements ou les villes des pays les plus divers sont heureux de la recevoir chez eux. Nombreux sont ceux qui lui consacrent, par plaisir ou par obligation, une bonne portion de leur temps. Beaucoup soulignent la nécessité d'étudier ce phénomène. Sans conteste possible, son avenir s'annonce encore plus brillant que son passé.

L'U. A. I. n'est pas restée indifférente puisqu'elle s'en occupe sur trois plans distincts : en tenant à jour l'inventaire de ses manifestations, en étudiant ses techniques, en dressant la bibliographie des ouvrages qui la concernent.

Elle fait sans doute plus que quiconque pour lui bâtir un avenir heureux et fécond et si cette personne morale centenaire qu'est la réunion internationale pouvait parler, elle dirait certainement : « Que tous ceux qui m'utilisent à toutes les sauces fassent un effort pour mieux me connaître, en se servant de l'International Congress Calendar, des ouvrages de la collection " La Science des Congrès internationaux " ainsi que de la Liste courante mensuelle des comptes rendus de congrès internationaux, publiés par l'Union des Associations Internationales. Parce que je ne veux pas paraître surannée, mais rester au contraire jeune et efficace, avec un modernisme de bon aloi ».

Dans l'un des volumes du Mémoir de l'Exposition de Bruxelles 1958 intitulé « les messages et les congrès » sur lequel nous aurons l'occasion de revenir, un remarquable aperçu statistique relatif aux congrès est dû à Louis van Meenen, Directeur de la Section des Congrès et Conférences. Tous les différents aspects du phénomène congrès tel qu'il s'est déroulé à Bruxelles pendant cette année 1958 y sont étudiés : nature des congrès, répartition des congrès par mois, nombre de journées, durée des réunions, classification des congressistes, nombre de congressistes, représentation étrangère, nombre de séances, nombre et nationalité des orateurs, nombre d'exposés, de langues, utilisation de la traduction simultanée, dans quelles langues, nombre d'interprètes, projections de films et de diapositives, publication de rapports, nombre de langues dans les rapports, droits de participation, durée de préparation des congrès, etc...

426 congrès ont été organisés entre le 17 avril et le 19 octobre 1958 sous le patronage du Commissariat du Gouvernement près l'Exposition: 346 internationaux, 80 nationaux. Le mois le plus chargé a été celui de septembre. La durée moyenne s'établit à un peu moins de 4 jours. 200.000 congressistes ont participé aux travaux des congrès. Le nombre moyen des participants s'établit à 438 pour les congrès internationaux; cependant les congrès groupant moins de 250 participants constituent 59 % du chiffre total. La moyenne des orateurs par congrès est de 25 : 68 % de ceux-ci sont des étrangers. 32 % des congrès ont utilisé 3 langues, 26 % 2 langues, 17 % 1 langue, 14 % 4 langues, 6 % 5 langues. Pour les 323 congrès ayant communiqué la durée de

préparation de la session, 60 % indiquent 3 à 6 mois, 22 % 7 à 12 mois. On pourrait ainsi glaner de nombreuses données dont la recherche jusqu'ici n'avait pas encore été entreprise systématiquement.

Il s'agit évidemment d'une ville déterminée, d'une période et de conditions exceptionnelles, mais la valeur d'échantillonage vis-à-vis du phénomène congrès en général est indubitable.

- Index ou non

Un jour un directeur de recherches dans une entreprise britannique apporta, fort irrité devant le conseil de l'ASLIB (association des bibliothèques spécialisées) des indications précises sur le nombre élevé d'ouvrages techniques dépourvus d'index qu'il avait le devoir de consulter dans sa spécialité. L'ASLIB estima que la question valait une enquête. A titre d'échantillonnage, tous les rapports de congrès, conférences et colloques, répertoriés par la British National Bibliography entre janvier 1956 et septembre 1959, portant sur les classes 500 (science) et 600 (technique), à l'exception de la médecine, au total 205 ouvrages, furent examinés. Le résultat fut des plus décevants : la moitié de ces ouvrages n'ont aucun index, plus de la moitié n'ont pas d'index par sujet, seulement un quart possèdent à la fois un index des auteurs et un index par sujet. On peut vivement regretter que les organisateurs de réunions qui accordent à celles-ci leurs meilleurs soins négligent un des fruits essentiels du congrès : le compte rendu. En effet n'est-ce pas le négliger, que de le priver de compléments devenus de plus en plus indispensables dans le flot croissant des publications ?

- International library

The first International Library for Scientific Films is to be set up in Brussels as a result of an agreement between the International Scientific Film Association and the Belgian Institut National du Cinéma Scientifique. Final documents are likely to be signed some time in 1961.

Unesco has suggested a study be made on the production of films in the natural sciences for use in high schools in newly developing countries. The International Scientific Film Association has been asked to undertake the research, and a commission was set up for this.

About 350 delegates from 36 countries, 12 recognised private operating agencies and 6 international organizations are expected to participate in the work of the Plenary Assembly.

The International Geological Congress has accepted the Government of India's invitation to hold its next session in 1964 in India.

The Congress is the most representative international organization in geology and its sessions are usually attended by over 2,000 delegates from nearly every country of the world.

The Congress is held for the advancement of investigations relating to the study of the earth, considered from theoretical and practical points of view.

The first International Geological Congress was convened at Paris in 1878. The 22nd Session to be held in India will be the first meeting of the Congress in an Asian country.

Twenty two news editors and chief sub-editors participated in a 11-day seminar in New Delhi October last. It was organized by the International Press Institute as a part of its two-year programme of technical assistance to the press in Asia, and was the first of this kind in this continent.





- How to follow up congresses

The Institution of Mechanical Engineers arranged a symposium in London on 27-28 September 1960. The primary object was to discuss the British papers presented at the 1st International Congress of the International Federation of Automatic Control, held in Moscow from 27 June to 7 July 1960, for the benefit of those who were not able to attend the Congress itself.

The more important contributions to the Moscow proceedings were briefly reported, and pre-prints of the papers were available in advance of the symposium.

• Documentation at conferences

"As attendance at international conference tends to become larger and the programmes more congested, there is an unfortunate tendency for papers to become shorter and more specialized, so that the Proceedings of such conferences are largely unintelligible to workers outside a narrow field. In fact, many of the short papers contributed to such meetings present detailed experimental data which arouse little discussion and would be more adequately dealt with by straight publication in journals of the learned societies. An entirely different situation occurs in meetings where the number of papers is limited, and adequate time is available for experts in neighbouring fields to present a more general review of present status, tendencies and difficulties in their respective subjects. With adequate time for discussion, attendance at such meetings can be very profitable not only by allowing informal interchanges between specialists but also by providing others with a feeling for the prevailing current of thinking in each subject, which cannot be obtained by reading the specialist literature. As the Hon. Lester B. Pearson says in his foreword to Professor Taylor's study, the Indonesian question was an early and difficult test for the United Nations, and its intervention there established a pattern of policy, if not machinery, for the future. He also points out that " We have made progress in recent years, halting and limited if you will, but some progress toward the prevention of war by collective action. Why have we been unable to make even the same amount of progress in assisting the growth to national independence from colonial status by planned collective action and fay international support for the emerging States on a broad and acceptable basis " ?

The present book provides an authoritative account of the Dutch/Indonesian conflict, and of how the UN tried to find a solution acceptable both to the protagonists and to the international community at large. Having himself taken part in the field machinery, as official spokesman of the UN Commission for Indonesia, having attended the Round Table Conference at The Hague in 1949, and having returned to Indonesia for the transfer of sovereignty and the post-transfer period in 1950, Professor Taylor is eminently qualified to explain the intricacies involved in the process of achieving Indonesian independence. He also does his best to answer Mr Pearson's query by using the material as a case study of the activities and effectiveness of the UN in the field of pacific settlement, that is to say under Chapter 6 of the Charter.

Those who are concerned with the development of regional co-operation, whether in the form of common markets, cultural exchange, or what-not, could profitably study the background and history of Scandinavian co-operation. No-one could be better qualified to expound the subject

than Dr Wendt, who has been connected with the Norden Association since 1943. The latter is a voluntary association having some 500 local branches in Denmark, Finland, Iceland, Norway, Sweden and the Faroe Islands. Where problems can only be solved through government intervention, the Association tries to exert indirect influence by rousing the interest of the general public; in cultural life it tackles the problems directly, and it has introduced many forms of cultural co-operation between the Scandinavian peoples.


