# Paul Otlet

*a centennial tribute*

### *Portrait of a Pioneer*

Paul Marie Ghislain Otlet was born in Brussels on August 23, 1868. It is fitting that this year, the centenary of his birth, should not pass unnoticed in this journal, for he it was, in collaboration with Henri la Fontaine, who founded the Union of International Associations (UIA) in 1910, an event which represented for them both a culmination of nearly twenty years of close collaboration in the area of non-governmental international organization. For Otlet, ever an idealist, it represented a full expression of the great though then unformulated task, to the performance of which he had aspired and directed his life in earliest youth.

Reluctantly he had gone to the bar in 1890 after studying at the Universities of Louvain, Paris and Brussels. Though a *stagiaire* of the brilliant and versatile Edmond Picard, a life-long friend of his family and an early influence on his own intellectual development, he could not suppress his impatience with the minutiae of the practicabilities of the law in action. But in the intellectually lively circle of barristers concentrated on the Palais de Justice of Brussels he did find his *métier* — not that of lawyer, but that of bibliographer and by easy successive stages, internationalist. Both Picard (originator of the *Pandectes Belges*) and La Fontaine, who "was also an advocate at the Court of Appeals and who had, on occasion, collaborated with Picard, were interested in bibliography, and it is not surprising to see Picard's former *stagiaire*, and the older La Fontaine set up an International Office of Sociological Bibliography in 1893. But this was only a beginning.

They called an international conference on bibliography in 1895 which created an International Institute of Bibliography (I.I.B.). At the same time the office of sociological bibliography was expanded and was recognised

by Royal Decree as the International Office of Bibliography (I.I.B.), which the Belgian government then supported with handsome annual subventions. The two complementary organizations proved successful and were followed by offices of specialised bibliography or documentation, set up within the central office by various societies which were to assume responsibility for the special subject areas in their competence. There followed a collective library of learned societies located in Brussels, and in the same year, 1907, a Central Office of International Associations, for Otlet and La Fontaine "were now in the grip of an everbroadening vision of internationalism for which they sought institutional expression. Why should not all the international associations, which together covered, then as now, nearly every field of scientific, social and economic endeavour, be brought into some rapport, the one with every other? Organised, could they not contribute towards the synthesis of knowledge so devoutly to be wished (at least by Otlet), the control of the bibliography on which such a synthesis must be based, and the development of a better world ? The Central Office studied these questions and called a very carefully organised conference in 1910, the year of an Universal Exposition in Brussels. The result : the Union of International Associations, and Otlet a Commander in the Civil Order of Alfonso XII of Spain, the only public recognition he received for his work during a long life.

The Union's beginnings were auspicious. The Office published the *Annuaire de la Vie Internationale* and the scholarly, well-received periodical *La Vie Internationale* for the latter of which it had a subvention from the Carnegie Peace Fund. Otlet organised, an International Museum to conserve what exhibits he could get of the International Exposition. A second conference of the Union

was called in 1913, and was even more successful than the first. There was talk of creating an International University as a necessary part of the various ventures now apparently flourishing. But the war, that " monster indecent and imbecile, shaggy with dispatches " breaking down these fragile structures of institutionalised internationalism, swept over Europe. Otlet, one son lost in the earliest days of the war, the other taken prisoner by the Germans, fled to France, La Fontaine to America. In the very teeth of the war, Otlet had had published clandestinely in Belgium and in the name of the U.I.A., his *End of the War* which contained a World Charter for organising a society of nations. All his efforts in France were directed unflinchingly (for he fell under suspicion of disloyalty and had moments of difficulty with the French government) towards the moment when the horror would cease, and the society of nations could be established. His views were expounded at a variety of conferences, lectures, and study sessions, and in many publications, the major ones of which were issued in the name of TJ.I.A. In high hopes he saw the creation of a League of Nations. On behalf of TJ.I.A. he proposed and La Fontaine, one of Belgian's delegates to the first sessions of the League, presented the proposal, that the League should create an organ for intellectual cooperation. Both hoped to see the U.I.A., non-political, non-partisan, potentially embodying *so much* of the wisdom of mankind, play an important role in the work of such an organ. But the League Commission and later Institute on Intellectual Cooperation, though it offered token formal approval of the organisations Otlet and La Fontaine had created and were now trying to resuscitate, went its own way under the patronage of the French government.

Otlet despite the international checks he received, managed, however, to have the I.I.B. and U.I.A. and the Internation Museum installed in part of the Palais du Cinquantenaire in Brussels, the whole being labelled the Palais Mondial or Mundaneum. There were even held several sessions of an International University. But troubles fell thick and fast about him in the very moment of his success, for upon him devolved the administration of the unwieldy complex, the Palais Mondial, which he increasingly, and justly, regarded as his own. The Belgian government, no longer as full of associates and friends as before the war, became recalcitrant, and after 1924 most of Otlet's efforts were directed towards keeping all his institutes together under one government-supported roof and accessible to the public. At the same time his thinking became more and more general, and he seemed to lose touch with the realities surrounding him and his institutes, though he saw clearly and with pain the weaknesses of the League of Nations and that Europe was headed inevitably towards another world war. La Fontaine, an old man now, was occupied with his duties in the Belgian Senate and in the deliberations of the Interparliamentary Union and the Universal Peace Congresses. Perhaps lacking the continuous, close contact with the more realistic, more gregarious man of public and political affairs which he had had before, and under constant stress from those unsympathetic to his life's work, he gave way to a passionate proselytising for his Palais Mondial and for an extraterritorial World City. He pursued fervently his dream of creating some kind of intellectual synthesis of the world, a first practical exercise in which might be thought the Universal Decimal Classification, the latest his treatise, *The World*.

In his later years, thin, stooped, peering through small steel-rimmed spectacles, surrounded by files and papers, he was a venerable, slightly eccentric figure. His idealism, his integrity of purpose, a burning moral fervour, never lessened in these years when he was neglected and misunderstood. Many of the friends made in the course of his bibliographical and internationalist activities lasted until his death. There is still, to-day, a number of associates who carry on the work he began. He must be considered an important figure in the international movement of the first twenty of thirty years of the century. Some of the organisations he and La Fontaine created have survived, though inevitably altered through the force of circumstance and by the mere passage of time. The U.I.A., as it now exists, was reactivated some years after his death, with a new structure and new

activities which are more easy to control and implement, but its roots clearly go back to 1910. Until recently the International Federation for Documentation followed closely the general course of the I.I.B. and it is perhaps as the "father" of documentation that Otlet has been most influential and will most be remembered. But no one interested in his work can fail to pay tribute to his idealism, the wider vision. He was, in the terms inscribed by his wishes on his tomb, "rien sinon mondialiste".

# A Simple Decision Game as Training Aid for NGO Officers

## *Introduction*

Much use is currently being made of management games as a means of training administrators in business and government organizations. The purpose of this article is to describe how such a game was prepared and used as a training aid for the officers of national and international non-profit organizations.

## *Purpose of Decision Game*

I was responsible for the organization of the Third International Training Seminar for youth leaders held under the auspices of the World Organization of Young Esperantists. The seminar was open to officers from all types of youth organization, not only those with Esperantist connections. The program of the seminar was designed to cover general techniques required in the administration of a national or international NGO such as : editing a newsletter, financial problems, general administration, organization of discussions, development of organizational structure, the position of international organizations in society, etc.

The idea of using a management or decision game was suggested to me by an article by A.J.N. Judge in, a previous issue of this magazine (October 1967). This discussed the many ways in which the technique could be employed by NGOs. A game offered the possibility of forcing the participants to make

practical use of some of the information that they had acquired during the previous days of the seminar. They could attempt to put into practice what they had learnt, note the consequences of and learn from their decisions — all without paying the price of their mistakes in loss of funds, morale or prestige, that would result from incorrect decisions in their own organizations.

A simple game could obviously not be designed to test all aspects of an NGO officers administrative ability. The purpose of the game that was finally used was to :

- bring participants into general contact with management techniques to give them a chance to learn new methods
- help them to understand the possibilities of the game as a technique which they could develop and modify to serve as a training aid for their own members.

## A. PREPARATION AND GENERAL COMMENTS

### *Preparation of Decision Game*

The preparation of the game required about two days of work on my part. I had never constructed any such game before and have never actually participated in a management game. This is a good indication that the development of these aids does not require sophisticated mathematical or expert knowledge.

The procedure adopted was briefly as follows :

- the real life activities which had been stressed in the seminar were examined to find those which could be conveniently be incorporated into a game
- the main decisions that have to be taken for each such activity were selected
- the criteria of a participant's success resulting from correct decisions in a particular activity (e.g. organizing a conference) were converted into financial effects on the organization's budget and a quantitative index measuring the influence on the general success of the organization
- the effects of each decision on the finances of the organization and on its qualitative success were worked out using common sense and a few arbitrarily selected constants which are obvious from the game-organizer instructions given below. (For example Graphs 1 and 3 were worked out purely on the basis of my past experience plus common sense. They could easily be modified to suit organizations whose members and subscribers react in a different way to changes in dues and magazine prices. Graph 2 was developed from actual office costs plus information from a printer). The relations between decisions and effects were juggled to give a coherent simulation of working decisions in an 'average' organization. This was of course done in the light of my own experience in organization administration
- the instructions to participants and to the game-organizer were then typed out in preparation for a test run.

#### *Preliminary Test Run*

Only one test run was required using three colleagues and myself. Very few corrections were necessary. A few of the arbitrary quality index constants were modified together with some of the financial cost figures when it appeared that one participant was getting unrealistic results after the effects of his decisions were worked out.

#### *First Use of (lie Game*

During the training seminar half a day was reserved for the decision game. The participants were divided into four groups of four participants each. Each group representing an organization and its officers. The operation of the game from the participants' and the game organizer's point of view are explained in the second and third parts of this article.

#### *Conclusions*

The main difficulty that became apparent during the game was the large number of simple arithmetical calculations which the game-organizer had to do in order to supply the results to each group of participants between each round of the game. In any future game one game organizer should be responsible for two groups only in order to avoid unnecessary delays.

The game should go through four trial rounds and then be stopped in order to see whether participants have understood the game and to give advice where necessary.

A possible refinement that might be introduced is to penalize any organization (by reducing its quality index) if officers are not fully utilized. A slightly more complex and realistic game could be developed if the participating groups were forced to compete with one another to attract membership support and subscribers from a limited number of potential members in a common pool. The membership and magazine readership achieved at the end of the game would then give a simulated indication of the value of the respective policies of the different organizations. This would make the game more interesting.

At the end of the seminar participants were asked to rank the various elements of the course. The game was voted into the middle of the ranking. A better result would probably have been obtained if it had first been explained more clearly. My first impressions are that it would be difficult to develop it into a major instructional technique. It does however appear to be a very useful means of introducing an interesting and instructional

variation into a series of dry lectures and discussions. It helps to relate the component parts of the course for the participant. A great deal depends on the game-organizer's evaluation of each group's progress at the end of the game.

## B. INSTRUCTIONS TO THE PLAYERS

(Players may be organized into groups of 2, 3 or 4 persons. Prior to these instructions being handed to players a verbal explanation is given about the purpose and form of the decision game in general (see for example the article in the October 1967 issue of this magazine). The currency used for the game was Dutch guilders although of course any currency could have been used. Approximate equivalents are 1 guilder = 1.4 French frs = 2/3d. sterling = \$ 0.28).

Imagine that you are the leader of an association whose officers hold quarterly Executive Committee meetings. On the occasion of these meetings, decisions are taken regarding the forthcoming activities of the association. The meetings are held every "year" (during the course of the game) on :

1st April (together with the Annual General Meeting)

1st July

1st October

1st January

At every meeting (i.e. round of the game) decisions may be taken regarding :

- the organization of a national meeting to be held in 5 months' time
- the organization of a training seminar to be held in 5 months' time
- the organization of an enquiry concerning potential interest in a training seminar. The results of this survey will become available in 3 months' time.

At the Annual General Meeting (1st April), decisions may be taken regarding the following (in addition to the above decisions) :

- representation of the association at the conference of the international association of which your association is a member.

The conference is held every year in July — membership dues for the following year (commencing on the 1st January) and membership recruiting campaigns during the course of the year (from 1st July to 31st December). These decisions will affect the membership figure which will become available on 1st January

- the number of magazine subscribers obtained will become available on the 1st January of each year, at the same time as , the membership figure, since it is on this date that membership contributions and subscription are due.

The above decisions must be written on a sheet of paper which is handed to the game-organizer at the end of every four months of 'game-time'. A copy of the decisions must be kept by each participating group. The game-organizer determines the consequences of your decisions, notes them down on paper, of which he hands you a copy. This information is used as the basis for the decisions at the next Executive Committee meeting. After a number of years of 'game-time' have elapsed, the game-organizer stops the game and the results are discussed. For example the results of the decisions of the different participating "national associations" are compared with one another. These results are expressed by means of three figures : the financial position, an index figure expressing the "quality" of the activities, and the number of officers required to operate the association.

Financial position : income and expenditure resulting from the association's activities are indicated in guilders on each result form.

Quality-index : the quality of each activity (which may be of importance to the future success of your association as it will affect the reputation amongst potential and current members). It is expressed by means of an index between 0 and 9. (A separate quality index is used to indicate the quality of the international organization to which your association belongs.) The sum of the index figures for a whole year indicate, on the 1st April (Annual General Meeting), your non-financial ability for

the elapsed year. A total of 20 is considered "normal".

Officers : There are 6 officers, including a President, a Secretary, and a Treasurer, to whom the " daily administration " is entrusted. The other three officers may be placed in charge of any of the above-mentioned activities (e.g. organizing meetings, surveys, etc.). Data given about each activity includes an indication of how many officers are required to do the work and how long they are required. At no time should there be work for more than 3 persons.

#### *Additional Information*

Your association is a national association, but it is a member of an international association. Your members are between 17 and 25 years old. They are evenly spread throughout your country. You have a central office/secretariat, where administrative work is done on a salary basis. You should not rely on subsidies, except for training seminars. Apart from any special activities, the fixed costs of operating your association amount to 500 guilders per year.

You start with an Annual General Meeting, for which the following details are supplied to you : starting budget, number of officers at work (This work only consists of editing a magazine).

Starting position : There are 600 subscribers to a 20 page magazine, issued quarterly, costing 1.5 guilders per copy (6 guilders per year). It is printed by offset. 350 of these 600 subscribers pay additional dues of 5 guilders per year as members (i.e. they pay a total of 11 guilders per year). These 350 persons are the actual members, the other 250 being subscribers but not members.

These details on the starting position are valid until 31st December of the first year of ' game-time '. You may decide at the Annual General Meeting whether some details (magazine price, number of pages, etc.) should be changed from the 1st January of the next year.

#### DETAILS ON SPECIAL ACTIVITIES

##### *A. National Meeting (one weekend)*

Decision required : can be taken at any Executive Committee quarterly meeting;

Results : meeting is held 5 months from the date of the decision;

Effects : the benefits of the meeting to your association will be made available to you in time for the quarterly meeting to be held in 6 months' time;

Officers : from the moment the decision is taken, until the results are communicated (in 6 months' time), one officer is fully employed by this activity;

Costs : program preparation costs are 200 guilders.

##### *Influences on effects :*

— factors beyond your control

— success of a previous meetings (as measured by your quality index), the chance of having a good lecturer, weather, success or failure to obtain suitable participants;

— consequences of decisions (which you must give to the game-organizer) on :

— 1. Is the meeting to be held in a centralized location or in the country ?

##### *Central Country*

Travel expenses per person 8 guild 16 guild

Accommodation reduction 0 10 %

— 2. What amount of travel expenses is refunded to each participants ? 0 -25 - 50 - 100 %.

— 3. Is the meeting to be held at a luxury conference centre (24 guilders for 2 days accommodation), or a youth hostel (16 guilders for 2 days) ?

— 4. What is the registration fee ? 5 - 10 - 15 - 20 guilders.

— 5. Will the central office be responsible for organizing the meeting, or will you delegate this to the local branch ?

*Central* : 40 hours at 5 guilders per hour salary.  
*Local* : 4 hours at 5 guilders per hour  
(The second alternative is cheaper, but there is greater danger that the organization will be unsatisfactory).

#### B. Training Seminar

Decision required : can be taken at any Executive Committee quarterly meeting

Results : course is held 5 months after the date of the decision;

Effects : the benefits of the course to your association will be made available to you in time for the quarterly meeting to be held in 6 months' time;

Officers : from the moment the decision is taken, until the results are communicated (in 6 months' time), one officer is fully employed by this activity;

Costs : program preparation costs are 200 guilders ;

Subsidies : 200 guilders.

It is expected that as a result of the course, your officers will work with increased effectiveness and that members will be able to give some assistance. This means that during the year following the course, your " administrative capacity" will be greater than 3 officers. The extent to which it will be increased will depend on the number of participants and the quality of the course.

If as a result of the course 1 " extra officer " becomes available for administrative work (bringing the total to 4 officers), this is expressed in the following way for calculation purposes. The number of officers available is still 3, but their effectiveness is increased by 1. You may therefore assume that you then have one extra officer.

Influence on effects :

factors beyond your control

— as under " national meeting "  
consequences of your decisions (which you must give to the game-organizer) on;

— 1. Is the meeting to be held in a centralized location or in the country ?

Travel expenses per person 8 guild 16 guild

— 2. What proportion of travel expenses is to be refunded to participants ? 0 - 25 - 50 - 100 %.

— 3. Is the meeting to be held at a luxury conference centre (24 guilders for 2 days accommodation), or a youth hostel (16 guilders for 2 days) ?

— 4. What is the registration fee ? 5 - 10 - 15-20 guilders.

— 5. Will the central office be responsible for organizing the meeting, or will you delegate this to the local branch ?

*Central* : 40 hours at 5 guilders per hour.

*Local* : 4 hours at 5 guilders per hour. (The second alternative is cheaper, but there is greater danger that the organization will be unsatisfactory).

— 6. Will you first arrange a survey on potential interest in the course ? If so, the game-organizer will supply you (at the next quarterly meeting) with an estimate of the number of participants in the program which is of greatest interest. You will only then have to decide whether you will organize the training seminar for 5 month's later. The survey will require 10 hours office-work at 5 guilders per hour. One officer will be fully employed from the moment the decision is taken until the moment the results are communicated. If no survey is made, no costs nor employment of officers are involved, but you will not know approximately how many participants to expect.

#### C. International Conference

Decision required : can only be taken at the Annual General Meeting (1st April);

Results : the conference is held in July;

Effects : the benefits of the meeting to your association will be made available to you in time for the October meeting;

Officers : the number of officers concerned depends on whether the delegation is briefed prior to the conference or whether any effort is made to analyse their observations and comments on the conference (see 3 and 4 below) ;

Travel and accommodation : 300 guilders per participant.

If you intend to send a delegation, you must inform the game-organizer :

— 1. The number of delegates from your association ? 1 - 2 . 3 - 4 - 5 - 10 - 20.

- 2. Costs to be refunded to participants ?  
10 - 25 - 50 - 100 %.
- 3. Will you advertise in order to obtain the most qualified participants from your association and will delegates be briefed ?  
If so, costs amount to 50 guilders plus the employment of one officer from 1st April to 1st July, if not, no costs are involved.
- 4. Will you analyse the observations and comments of your delegation on their return ? Will you publish the results of this analysis ? If so, the costs amount to 50 guilders plus the employment of one officer from 1st July until 1st October.  
If not, no costs are involved.

#### D. Magazine

Decision required : can only be taken at the Annual General Meeting (1st April);

Results : during the year from the following 1st January onwards. From the time of your decision (1st April), you have the opportunity to advertise the (possibly changed) subscription rates, which will be in force from 1st January;

Effects : the benefits of the decision to your association will be made available to you on 1st January. You will be informed about the number of subscribers for that year as a consequence of the subscription rates that you have chosen;

Officers : the amount of time spent by one editor/officer will depend upon the number of pages which you decide to publish every year and can vary between 0.5 and 1.5 officers during the forthcoming year.

You must inform the game-organizer :

- 1. How many issues of the magazine there are per year ? 4 - 12.
- 2. How many pages there are in a copy (A4 size) ? 8 - 16 . 20 - 32.
- 3. What is the price per copy ? 0.25 - 0.75 - 1.0 - 1.25 - 1.50 - 1.75 - 2.0 guilders.
- 4. Will the magazine be : stencilled in the central office or printed by offset printer externally.

- 5. Is the editor specially qualified (i.e. has he attended a training seminar during the past 2 years). Yes No  
Note : It will be up to the game-organizer to decide whether you receive or have to calculate yourself the costs of stencilling and printing.

#### E. Member Recruitment

All members are subscribers. There are however subscribers who are not members. In the game this is translated as follows. The game-organizer first indicates the number of subscribers (as a result of your decisions), then he determines what proportion of these subscribers will also be become members (as a result of the decisions listed below).

Decision required : can only be taken at the Annual General Meeting (1st April);

Results : you may decide to have a recruitment campaign from 1st July until 31st December. The subscription remains in force for the whole year from 1st January;

Effects : any changes in membership will be made available to you in time for the meeting on January 1st;

Officers : the recruitment campaign involves the employment of one officer during a period of 6 months (see below).

You must inform the game-organizer;

- 1. The amount of membership dues for the coming year : 0 to 10 guilders.
- 2. Do you plan a membership campaign ? If so, this requires 20 hours office work at 5 guilders per hour, plus other costs, making a total of 200 guilders. One officer will be occupied from 1st July until 31st December. If no, no costs are involved.

The overall quality index figure will also affect the number of members, to show the influence of the association's reputation on membership.

#### F. Secretariat

Fixed costs (travel, office, other expenses) amount to 500 guilders per year (on 1st April).

### C. INSTRUCTIONS FOR THE GAME-ORGANIZER(S)

During each round of the game, namely the quarterly meetings, participants note down their decisions on slips of paper. These are handed to the game-organizer when ever all the decisions have been taken. He then works out the results on the basis of the sim-

ple arithmetical calculations listed below. They have been numbered in the same way as the decisions listed in Part B. The results when determined are then handed to each group on a slip of paper. Results requiring 5 or more months to be put into effect are delayed and kept by the game-organizer to be handed to the group in time for the appropriate meeting.

#### A. National Meeting Results

These results are only calculated if the group has decided to organize a national meeting.

Factors beyond the group's control :

- note fixed expenditure of 200 guilders = A.
- choose an approximation to the number of meeting participants by calculating any percentage of the total membership between 6 and 10 % = (i.e. P %). The percentage figure used could be picked out of a hat. This arbitrary choice approximates the unknown factors which influence the success of the meeting. Therefore : current membership X P/100 = B.
- choose the provisional index of the quality of the meeting by picking any number between 4 and 7 (i.e. C). (The choice could be arbitrary based on an average figure of 5. This is necessary for the first round. The final quality index for the previous national meeting can be used, but preferably 25 % of the last overall quality index figure, i.e. 25 % Z, which is calculated in the last section).
- Influence of likely success of meeting on number of participants. Work out B X (C + 5)/10 = D which is a revised number of possible participants.

Decisions made. by the group :

The effect of holding the meeting on the general reputation of the organization is therefore N. (5 is an average value).

The organization of the meeting fully, occupies one officer for two rounds (or six months). The figures G, K, L and N are given to the group in time for the second meeting after the decision was taken.

#### B. Training Seminar Results

These results are only calculated if the group has decided to organize a training seminar. If only a survey is required then no other costs are calculated

Factors beyond the group's control :

- (a) note fixed expenditure of 200 guilders = A
- (b) note subsidy of 200 guilders = B
- (c) choose an approximation to the number of seminar participants by calculating any percentage of the total membership between 3 and 5% (i.e. W %). The percentage figure could be picked out of a hat. This arbitrary choice approximates the unknown factors which influence the success of the seminar. Therefore : current membership X P/100 = C
- (d) choose à provisional program success quality index by using the quality index achieved for the last seminar, or otherwise 5, giving = D. Work out  $5 + (D-5)/2 = E$ .

(e) influence of likely success of seminar on number of participants. Work out C X (E •+• 5), 10 = F. Which is a revised number of possible participants.

The quality index for this activity is therefore S (5 is an average value)

The organization of the seminar fully occupies one officer for two rounds (or six months). The improvement in the effectiveness of officers is worked out from  $6 \times$  current membership  $X S/100 = T$ . This gives the new number of officers which may be assumed to be active. The minimum is 6 and fractions should be rounded upwards.

The figures J, IL L, N, and T are given to the group in time for the second meeting after the decision was taken. If only a survey was required this is given in time for the first meeting after the decision was taken.

C. International Conference Results

The results are only calculated if the group has decided at the Annual Meeting to send a delegation to the international conference held every fourth round. (A possible refinement would be to lower the quality index whenever the group decided not to • send a delegation).

Then go horizontally to the vertical line. The figures there give the percentage (i.e.  $E$  %) of the total possible purchasers of the magazine which will actually subscribe. (If the editor has recently attended a training seminar his style will attract more possible readers. This is assumed arbitrarily to increase the potential market from 2,000 to 2,400).

Magazine circulation,

The final magazine circulation is  $F$  subscribers for the year.

Use Graph 2. Select the line appropriate to the chosen magazine. Go up from the number of subscribers (calculated as F) above given on the bottom line to the line representing the chosen magazine. Then go horizontally to the vertical line at the left. The figure there gives the total printing cost (i.e. J guilders) for each issue of the magazine.

Work out annual printing cost for

$$\text{either } 4 \text{ issues per year} = J \times 4 = K \text{ guilders}$$

$$\text{or } 12 \text{ issues per year} = J \times 12 = K \text{ guilders}$$

The total annual cost of printing the magazine is therefore K guilders. All other costs associated with production and distribution of the magazine are assumed to be included in the fixed costs of running the secretariat (i.e. 500 guilders per year).

The editor is assumed to be occupied as follows :

4 issues of 8 pages per year — 6 months

12 issues of 32 pages per year — 18 months

~ other combinations are intermediate between these two limits

E. Member Recruitment Results

These results are calculated in time for the January meeting each year.

Decisions made by the group :

(a) Effects of decisions on membership of the organization for the coming year

J. Membership dues (i.e. A guilders per member per year). Use Graph 3. Go up from A guilders on the bottom line to the curve. Then go horizontally to the vertical line on the left. The figures there give the percentage (i.e. B %) of the magazine subscribers (i.e. F from the previous section) which will become full members of the organization. Work out provisional number of members from  $F \times B/100 = C$ .

2. Membership campaign

Work out overall quality index for all activity for the past year (giving Z) from

National meeting N

Training seminar + S

Effect of past year's activities on membership in the coming year. Work out final membership from  $D \times (Z + 30)/SO = E$

The final membership for the year starting in January is E members.

(b) Effects of decisions on income

1. Membership (i.e. E)

Work out  $E \times A = F$  guilders.

The total income from membership dues is F guilders.

fc) Effects of decisions on expenditure

2. Membership campaign either Yes : 200 guilders = G  
or No : 0 guilders = G

N.B. If any of the effects resulting from these calculations appear unrealistic it is a very simple matter to alter the constants used to make it "harder" for a given group to succeed. From the calculations required it is fairly easy to see how further decisions could be added to the game to cover other aspects of the task of an NGO administrator, particular to a given organization. Games have been used in business to give a new Board of Directors an appreciation of the problems of an organization, *before* it starts modifying existing policies. They could possibly be used to give the national NGO committee acting as host to an international congress an appreciation of the difficulties that are likely to arise.



Magazine circulation achieved as a percentage of the total possible circulation.





Print process (meaning of lines from top to bottom) :







**Congrès** : Le 5 janvier 1968 a été fondée à Bruxelles l'Association Internationale des Organisateurs Professionnels de Congrès (International Association of Professional Congress Organizers (IAPCO)) C'est sous les auspices de l'Union des Associations Internationales que cette initiative se situe.

Cette nouvelle Association a pour but principal de créer et de maintenir un haut niveau dans l'organisation des réunions internationales, ainsi que développer l'étude des problèmes s'y rapportant.

Cette Association devait être créée car à l'heure où les congrès et autres réunions internationales vont se multipliant, il est indispensable de voir se grouper les professionnels sérieux, spécialistes de ce genre d'organisation.

L'Association est composée de deux catégories de membres effectifs et affiliés, afin de grouper et les organisateurs professionnels s'occupant exclusivement de l'organisation de congrès, et les représentants de « département congrès » dépendant de services officiels ou privés.

*The International Association of Professional Congress Organizers - IAPCO —, was founded, in Brussels under the auspices of the Union of International Associations. The principal aim of the new Association is to establish and maintain a high standard in the organization of international meetings and, in addition, to develop the study of related problems. The Association is composed of two categories of members, active and associate, in order to group together both professional organizers concerned exclusively with the organization of congresses and representatives of "congress departments" attached, to official or private undertakings. The secretariat is situated at : J, rue aux Laines. Brussels 1 - Belgium.*

Freer trade : The first meeting of a new International Chamber of Commerce body, the Joint Committee on Non-Tariff Obstacles to Trade, took place earlier this year in Paris. Mr Walter Hill, Secretary-General of the ICC, expressed disappointment that a year after the ending of the Kennedy Round discussions the situation did not live up to the hopes felt upon the conclusion of the GATT agree-

ments; and he pointed out the two main reasons why : the balance of payments problems of the United States, and the reaction of certain economic sectors against the importance of the liberalization measures taken by the GATT. The purpose of the new Joint Committee is to co-ordinate and plan the fight against the protectionist trends which are occurring. In the coming months the Committee will look at protectionist measures, including quantitative restrictions, the Added Value Tax system of the EEC, and the regulation for one reason or another of the sale of specific products : this in order to clarify the situation as it stands, to decide which measures are acceptable to its members, and most important to promote a resumption of the liberalization process by tackling the non-tariff obstacles which hinder international trade expansion.

Jeunes à la 1<sup>e</sup> Assemblée générale de la Cité internationale des jeunes a été inaugurée le 23 juillet 1968. Le thème général était « La jeunesse dans le monde d'aujourd'hui et de demain. Défis et Responsabilités » ; les discussions ont porté plus particulièrement sur les préjugés et les discriminations, le développement scientifique et techni-

que, les loisirs et les valeurs morales et sociales. La Cité internationale elle-même, créée à Tel Aviv a pour buts de permettre aux jeunes de différents pays d'apprendre à vivre les uns avec les autres, à mieux se connaître eux-mêmes et à respecter les idées des autres; d'exprimer leurs opinions sur le monde en général, et sur les problèmes qu'ils ont à résoudre; d'examiner le rôle que peut jouer aujourd'hui la jeunesse face à la science et à la technologie et la place que celles-ci détiennent dans l'élargissement des relations humaines; de disposer d'une tribune pour les discussions sur les problèmes des jeunes par les jeunes et pour un échange de points de vue entre jeunes et aînés sur les voies et moyens d'améliorer les relations humaines afin de promouvoir la paix.

*" Youth in the world of today and tomorrow - Challenges and responsibilities " was the theme of the first general assembly of the International Youth City held in Tel Aviv in July.*

**WACB looks to the future :**  
Conscious of the fact that the different media of communication are becoming more and more inter-related, particularly broadcasting and the print media, this year's Assembly meeting of the World Association for Christian Broadcasting, held in Oslo in June, created the World Association of Christian Communication, an amalgamation of the WACB and the Co-ordinating Committee

for Christian Broadcasting. The three main sections of the new organization will be the Department of Training, the Department of Information, Publication and Programme Evaluation and Exchange and the Department of Church-Related Communication : it is hoped that integration of the two organizations will be completed early next year. Plans for the future include the establishment of regional offices. The address of the WACC is the same as that of the WACB.

Organisation non-gouvernementale, celle-ci cherche à développer la mise en application, surtout dans l'instruction civique, des six principes suivants : l'école est au service de l'humanité; l'école ouvre à tous les enfants du monde le chemin de la compréhension mutuelle; l'école apprend le respect de la vie et des hommes; l'école enseigne la tolérance, qualité qui permet d'accepter chez les autres, des sentiments, des manières de penser et d'agir, différents des nôtres; l'école développe chez l'enfant le sens de la responsabilité, l'un des plus grands priviléges de l'homme; l'école apprend à l'enfant

à vaincre son égoïsme; elle lui fait comprendre que l'humanité ne peut progresser que par des efforts personnels et l'active collaboration de tous. Des renseignements peuvent être obtenus auprès de l'adresse suivante : EIP, 5-7, rue du Simplon, 1211 Genève 6, Suisse.

**CARIFTA :** The Caribbean Free Trade Area (CARIFTA) was formally established on April 30th with the signing of the relevant Agreement by the governments of Antigua, Barbados, Guyana, and Trinidad and Tobago. The West Indian Associated States deposited a document of intent at the ceremony announcing their signature for 1st July. Jamaica, on the other hand, announced that it would not sign the Agreement and would withdraw from the Regional Development Bank. The two bodies became effective on 1st May, 1968. At the signing ceremony, the Prime Minister of Guyana expressed his conviction that this was the first step toward economic integration so necessary to survival.

**Politique de l'eau :** Un organisme permanent chargé d'étudier les problèmes posés

par l'utilisation des ressources en eau et la pollution de celle-ci vient d'être constitué à Genève sous l'égide de la Commission économique des Nations Unies pour l'Europe. L'Organisation mondiale de la santé, l'Organisation météorologique mondiale, l'Unesco, la PAO, l'Agence internationale de l'énergie atomique, ainsi que l'OCDE et le Conseil de l'Europe participent aux activités de cet organisme. Celles-ci visent notamment à établir une « politique de l'eau », qui tienne compte de tous les aspects économiques et techniques des problèmes traités; à faciliter l'échange et la diffusion des renseignements et d'expériences; et à organiser des réunions et des voyages d'études.

*A permanent body for the study of problems raised by the use of water resources and pollution has been formed in Geneva under the auspices of the UN Economic Commission for Europe.*

**Knights of philately :** The International Fellowship of Knights of Philately, of which the Grand Master is Mr G. Blumental (13 Vrijheidlaan, Knokke, Belgium) will seek to further co-operation between philatelists all over the world and to reward "all those who, by their research and selfless efforts, render service to the cause of philately".

Droit des marchés européens : L'Ecole des hautes études commerciales de Copenhague vient de créer un Institut du droit des marchés européens (Institut for Europaeisk Markedsret, 10 Julius Thomsens Plads, Copenhagan V)- Cet institut va s'occuper des recherches et de l'enseignement sur le droit des organisations européennes, plus particulièrement de la CEE et de l'AELE, et son travail portera aussi bien sur les efforts faits pour l'unification du droit dans les domaines du droit civil, commercial et économique que sur l'étude de la structure de ces organisations et sur leur législation. Un service d'information renseignera les juristes Scandinaves sur la législation en vigueur dans les pays de la CEE, sur les décisions de la Cour de justice européenne et du Parlement européen. En plus, l'institut se chargera avec le concours de l'Ecole des hautes études commerciales, de traduire en danois la législation et les décisions administratives les plus importantes des Communautés ainsi que la jurisprudence de la Cour de justice.

*An Institute of the Law of the European Markets has been created in Copenhagen.*

Asian education : The education ministers of the Philippines, Thailand, Indonesia, Laos, Malaysia and Singapore have established a formal organization to replace their periodical meetings. They have signed a charter setting up the South East Asian Mi-

nisters of Education Council, which is headed by Singapore's representative, Ong Pang Boon. One participant expressed the hope that the council would help create an " invisible Asia ". Heavy fighting in Saigon prevented a South Vietnamese delegation from attending the meeting.

Library materials : SALALM (Seminar on the Acquisition of Latin American Library Materials) has now been formally incorporated in the District of Columbia, following the decision of the 11th annual meeting (1966) to put the organization on a more formal basis. Steps are now being taken to secure tax exemption and tax deduction status to enable it to carry out tasks requiring greater finance than that afforded by membership fees alone. The 13th annual meeting was held at the University of Kansas in June.

Encore une organisation étudiante : Au mois de mars dernier, un congrès qui a eu lieu à Besançon a réuni des étudiants en médecine d'une dizaine de pays d'Europe, y compris les six pays de la

CEE. Le thème du congrès qui était organisé par l'association française, portait sur l'évolution des études médicales dans le cadre de l'Europe. Les délégués ont réclamé une formation particulière pour l'omnipraticien qui, à leur avis, ne doit plus être considéré comme le parent pauvre du corps médical, vu son rôle toujours grandissant, aussi bien du côté des soins que de celui de conseiller de la famille et de l'homme. Le congrès a également vu la création du Comité de liaison des associations des étudiants en médecine de l'Europe des six, à laquelle se sont jointes les associations de Grande-Bretagne et d'Autriche parmi d'autres à titre d'observateurs. Le secrétariat provisoire du comité a été fixé à la Faculté de Médecine de Besançon.

*The recently founded liaison committee for the associations of medical students within the Common Market countries has its secretariat at the University of Besançon.*

Scientific journalism : The Ibero-American Association of Scientific Journalists was formed at the end of the 1st Ibero-American Seminar on Scientific Journalism held in Madrid last year. The President is Mr Arturo Aldunate Phillips of Chile, and the Secretary General Mr Manuel Calvo Hernando. Other countries represented are Brazil, Bolivia, Ecuador, Argentina and Uruguay. **Audience research** : GEAR - the Group of European Audience Researchers — which was formed last year in Hilversum has as its aims the exchange and circulation amongst its members of documents and reports on audience research with particular reference to the methods employed, and joint activities in research projects; all in the field of radio and television. The Group operates on a mutual basis without a secretariat : each member sends relevant material to other members, who are either from the EBU or, in Eastern Europe, from ORIT. Countries represented are Denmark, Finland, Italy, Netherlands, Ireland, Sweden, UK and Czechoslovakia.

Huit organisations européennes de radiodiffusion et de télévision ont créé un groupe de recherche sur l'audience de la radio et de la TV en Europe.

**Commerce international** : Lors d'une réunion qui s'est tenue au mois d'avril à la Nouvelle-Orléans, les représentants de vingt-cinq villes et ports américains et de six pays étrangers ont élu M. Van Heurck, d'Anvers, à la présidence de l'Association des « World Trade Centers » (Centres internationaux de commerce) qu'ils venaient de créer. Dans son discours, M. Van Heuck

a déclaré que la formation de cette organisation avait une signification historique et constituait la première étape vers l'établissement d'un organisme véritablement international pour les organisations privées et d'Etat qui se consacraient au libre commerce avec toutes les nations. L'association se réunira à nouveau au Japon en 1970 et son bureau exécutif à Anvers et à Montréal l'année prochaine.

**Central African Union** : The Presidents of Chad, the Central African Republic and the Democratic Republic of Congo have signed the charter establishing the Union of Central African States. One of the first decisions taken to implement the general principles of the charter was to place the transport systems of the three countries on a communal basis : air, river and rail. The air services will be run by Air Afrique Centrale. The Union's secretariat will be at Bangui, to be financed by a jointly-constituted fund, and further measures envisaged are the formulation of a joint policy governing the movement of labour among the countries, and the exchange of information on security matters.

**World prayer** : 82 years ago the World Day of Prayer was first observed in the USA. Now it is proposed that it shall be observed on the first Friday in March of each year, and to this end an international committee responsible for planning the event was set up at July's world ecumenical conference in Sweden. World Day of Prayer is observed by church women in 130 nations : the chairman of the committee is Gudrun Diestel of Germany.

**Exportations américaines** : Le Centre interaméricain de promotion des exportations (CIPE), nouvel organe de l'Organisation des Etats américains et fonctionnant sous le contrôle du Comité interaméricain de l'alliance pour le progrès, mais doté d'une relative autonomie de gestion, a commencé ses activités le 1<sup>er</sup> juillet 1968. Celles-ci sont orientées vers les études de marchés ; le centre offrira son assistance technique à ses membres et mettra à leur disposition un service d'informations sur toutes les questions relatives aux exportations. Il viendra en aide aux foires-expositions et aux campagnes publicitaires destinées à faire connaître à l'étranger les produits des industries manufacturières du continent. Dans l'immédiat, le CIPE se consacrera aux marchés des Etats-Unis et de

l'Europe occidentale. Le financement du centre sera assuré par les gouvernements membres.

*The Inter-American Centre for the Promotion of Exports, set up by the Organisation of American States, has been functioning since July this year.*

A starry future : Is astrology on the way to attaining serious respectability ? Certainly, if the recently formed International Society for Astrological Research (ISAR) achieves its object of restoring it as " one of the recognized disciplines of the scientific and academic world ". This latest creation of the United States plans to hold world congresses of astrology, to maintain a central library and data-computing centre, and to establish an International Institute of Advanced Astrological Studies.

blique sur l'Année internationale des droits de l'homme, d'une étude spéciale sur le racisme dans le contexte des discriminations qui mettent en danger les relations fraternelles de la communauté humaine, des relations de l'Eglise avec tous les mouvements et institutions qui travaillent pour la paix, et de paix, et de la préparation de la prochaine Journée mondiale pour la paix qui doit être célébrée le 1<sup>er</sup> janvier 1969.

Transports ferroviaires du Maghreb : Le 26 mars 1968 a été publié au « Journal Officiel de la République algérienne » le décret portant publication de la Convention relative à la création d'un Comité des transports ferroviaires du Maghreb (CTFM) dont le siège est à Alger. L'organisation, dont le but est d'assurer l'harmonisation des transports par chemin de fer entre les pays maghrébins, se compose d'un représentant de chacun des réseaux des chemins de fer tunisiens, algériens et marocains. Elle est également chargée des relations entre les réseaux du Maghreb et les autres organisations ferroviaires internationales pour l'ensemble des questions intéressant les trois administrations d'Afrique du Nord.

*The Tunisian, Algerian and Moroccan national railways have set up a common Com-*

*mittee for the Rail Transport of the Maghreb which has its secretariat in Algiers.*

African common market : Nine West African countries represented at a meeting in Monrovia last April have agreed to set up a regional economic grouping. They are Gambia, Ghana, Guinea, Liberia, Mali, Mauritania, Nigeria, Senegal and Upper Volta. A Council of Ministers will study a treaty defining the structure and role of the grouping at a further meeting in Monrovia next month, and the treaty will be signed by heads of state and government in April next year.


Arab petroleum : With the aim of facilitating the movement of oil from the oilfields to the consumer markets and ensuring reasonable terms in the market, Kuwait, Libya and Saudi Arabia have founded the Arab Organisation of Petroleum Exporting Countries. Membership is open to any other Arab country provided oil is one of the main sources of that country's national income, and provided its membership is approved by the organization's Council of Ministers. The Organisation's headquarters are in Kuwait.

In other cases the material can be obtained direct from the international organizations responsible for arranging the congress. Full information about such organizations, including of course their present address, can be obtained from the current (1965-67) edition of the Yearbook of International Organizations (UAI, 1 rue aux Laines, Brussels 1; 1008 p. 27X21 cm, \$ 20).

**The chronological listing is followed by a keyword index, references being according to congress dates.**

Entries for which precise dates are not available have been placed at the end of the relevant month or year, and they have been given a running number, prefixed by the letters " ND " (no date) from 1 upwards; the entry appears in the form " 1968 (ND 1) " as does the index entry at the appropriate keyword.

In cases where a particular congress has given rise to more than one publication the indication " (a) " appears after the date at the head of the first entry; subsequent entries for the same congress bear the indication " (b) ", " (c) " etc.

It has been agreed with the United Nations Secretariat in New York that United Nations publications should be excluded from our listings, thus avoiding overlap with the monthly and cumulated issues of the United Nations documents index (UNDI).

## **Projets de Nouvelles Organisations Internationales**

### **Plans for New International Organizations**

**Reprography** : At last year's Cologne meetings of the Permanent International Committee for Reprography, the most important decision taken was that whereby the committee was replaced by the International Reprographic Council (IRC). A small committee, under the chairmanship of Prof. Dr H. Amtz (Germany), has been assigned the task of drawing up the statutes which will be based on a draft already prepared by Mr van der Brugghen. The aim in forming the new Council is to bring it up to a level where it can be recognised and supported by governments all over the world, and the hope has been expressed that the Council will have a home and permanent secretariat through which to foster the progress of and education in reprography. Another decision of the Cologne meetings was that the 3rd congress should be held in London in March 1971.

**Balneology** : At an international balneotechnical symposium held in Warsaw towards the end of last year and attended by more than a hundred specialists from European countries, topics discussed included modern balneological devices, protection and utilization of springs and na-

tural curative resources, planning and development of spas, and international co-operation in the geology of balneological mineral resources. A post-symposium tour of Polish spas wound up the proceedings. It is planned to set up an International Information Centre of Balneological Technique in Warsaw.

**Bibliothèques municipales** : L'Association internationale des bibliothèques municipales groupera les bibliothèques des zones métropolitaines comptant au moins 400,000 habitants. Elle encouragera ces bibliothèques à coopérer à la fois sur le plan international et dans le cadre des travaux de la Fédération internationale des associations de bibliothécaires, et à procéder à des échanges dans tous les secteurs de la bibliothéconomie. La création de cette association a été recommandée par la section des bibliothèques publiques du Conseil général de la FIAB lors d'une réunion tenue l'année dernière à Toronto. M. Henry C. Campbell, directeur des bibliothèques publiques de Toronto, a été nommé secrétaire et trésorier honoraire de l'association, et M. George Chandler, de la Bibliothèque publique de

Liverpool, a été nommé président du comité directeur provisoire de l'association.

*George Chandler, of Liverpool Public Library, was elected president of the provisional executive committee of the International Association of Metropolitan Libraries at a meeting in Toronto last year of the General Council of the International Federation of Library Associations.*

**World peace** : Mr Randolph T. Major, Jr. has been appointed Development Co-ordinator to make the idea of a World Peacemakers Academy a reality. Mr Major, who began his work at the beginning of the year, will seek to establish close working relations with UN personnel and to develop support in all regions of the world for the world academy idea.

**Dental record** : A project has been put forward for the establishment of a Latin American Centre for Odontological Documentation in order to satisfy the need, ever increasing, for better access to technical and scientific information in this field. It is hoped that a future centre would co-ordinate certain activities of the Latin American odontological libraries and would serve as a documentation clearing

house for the universities and dental schools in general. The creation of such a centre is considered to be all the more important in view of the known deficiencies in the existing libraries devoted to dentistry, and it is felt that it would help to promote an improvement in dentistry and dental health in Latin America.

Porcs et volaille : Un accord signé avec le Programme des Nations Unies pour le développement pour la réalisation d'un projet coûtant 2,6 millions de dollars prévoit l'établissement d'un institut de recherche et d'apprentissage de l'élevage des porcs et de la volaille. Le centre devait être créé à Sembawang, près de Singapour. Le gouvernement de Singapour participe pour 1,6 million de dollars en espèces au coût. L'institut devait commencer à fonctionner au mois de septembre 1968. Il permettra à 13 pays de l'Asie du Sud-Est dont le Japon et l'Inde, de former des spécialistes d'un niveau élémentaire ou moyen.

*A research centre for pig and poultry breeding was expected to come into operation at the beginning of September at Singapore.*

Asian shipping line : An agreement recently concluded at a conference of the Association of South East

Asian Nations provides for a joint study on the proposed \$250 million integrated Asian Shipping Line. This would be undertaken by a permanent committee of technical experts, who would look into possible obstacles in Government and private sectors. A minimum fleet of 600,000 deadweight tons is envisaged, consisting at the start of 36 high-speed cargo liners of at least 12,000 dwt tons each, to maintain regular services to America and Europe, and 24 cargo vessels of 5,000-7,000 dwf. tons for regional service.

Computers for Asia : The UN Economic Commission for Asia and the Far East met in Bangkok recently to discuss the setting up of a Regional Computing Centre for Asia. It is hoped that the new centre will, initially, encourage the introduction of information technology in fields such as population and agricultural censuses, and aid Asian countries to train their own local staff.

Asian-Pacific museums : The 11th Pacific Science Congress, held in Japan in 1966, passed a resolution recommending the establishment of an Asian-Pacific Museums

Association, with headquarters at Bishop Museum, Honolulu, and regional offices elsewhere. In November, 1967, the Pacific Science Association's Standing Committee on Museums in Pacific Research sent out a questionnaire to about 600 museums in the area, as a first step towards the compilation of a Directory of Asian-Pacific Museums. In addition, it is hoped to publish a Newsletter and to promote other means of communication such as meetings and seminars directed at museum problems : it is felt that at the moment there is a serious lack of channels for the exchange of information of mutual benefit and of value to the scientific world in general. Chairman of the Standing Committee is Dr Roland W., Force of Bernice P. Bishop Museum, Honolulu. The 11th congress also recommended the establishment of a Volcanological Research Center for the various countries of the Pacific basin, and this resolution was endorsed at the end of last year by the International Union of Geodesy and Geophysics at its 14th General Assembly.

Développement agricole : La FAO, le BIT et l'Unesco ont conclu un accord de coop-

ration dans les domaines de la formation, de la science et de l'éducation agricoles ainsi que de l'emploi dans les régions rurales. Cet accord prévoit la constitution d'un comité consultatif conjoint formé de 18 membres, qui conseillera les directeurs généraux des trois organisations dans la planification et la réalisation de programmes en faveur de la promotion économique et du développement social.

*The FAO, ILO and Unesco agreed to set up a joint consultative committee to advise in the fields of agricultural training and sciences, and rural employment.*

Community development : The Netherlands Institute of Community Development has undertaken the setting up of a European regional clearing house for community work, and the Dutch Government has agreed to supply some of the funds for the initial stages. Eight European countries were represented at the meeting from which this project arose, out of concern at the present gap in a field where the health and welfare of people may depend on obtaining information quickly and efficiently to meet a specific need. The Clearing House will promote the exchange of information on all aspects of community work; it will also aim to act in a liaison capacity between professional individuals and institutions, to collect all relevant material and literature, to compile a bibliography of relevant works and to keep a record of work in progress

and of the people carrying it out. Where possible, information will be made available on request. Problèmes viticoles : Une conférence organisée par la FAO groupant les représentants de 26 pays a recommandé au mois de juin dernier la création d'un comité d'étude officiel qui se consacrerait aux problèmes du commerce international des vins, des raisins frais et secs.

*Delegates at a conference organised by FAO have called for a study panel to examine the problems encountered by the international wine and grape trade.*

Housing finance : ICFTU and the International Federation of Building and Wood Workers are two organizations who have warmly approved the recent proposition of a UN group of experts for the setting up of an International

Housing Bank. The organizations feel that governments, international bodies such as the World Bank, and large employers should co-operate to promote low-cost housing. To cite one suggestion put forward by the IFBWW, loans by the World Bank for industrial plant should carry the stipulation that a certain percentage must be used for housing.

Education : The World Confederation of Organizations of the Teaching Profession held its 3rd international curriculum conference in Oxford last year (a full report may be had on application to the organization's Washington office) at which 220 educators were in attendance. One of the propositions made was that there should be formed an international centre for the study of instruction which would be under the joint sponsorship of Unesco and WCOTP.

Elevage de la race « Hereford » : La FAO fait savoir qu'une « banque mondiale du sperme » va être créée par les éleveurs de bétail de la race « Hereford » de 17 pays du monde, qui veulent ainsi renforcer des races locales

de faible rendement, grâce à l'insémination artificielle. La PAO aidera à la formation de personnel spécialisé et distribuera le sperme des pays donateurs aux pays qui en feront la demande. M. Tony Morrison, Secrétaire-général du Conseil mondial de la race « Hereford » a déclaré que la race possède des qualités de résistance, de docilité et d'adaptation aux conditions locales les plus dures qui la rendent précieuse sous tous les climats, et les croisements réalisés pourraient « renforcer et améliorer le rendement des races locales, comme cela s'est passé déjà partout dans le monde où des Hereford ont été implantés ».

*A world semen < bank > is to be set up by breeders of Hereford cattle in 17 countries with the aid of FAO.*

Intersputnik : At the United Nations the USSR has proposed a new space communications system using artificial satellites. The Soviet spokesman said that the proposal would meet the needs of both the developed and the undeveloped countries, being " based on three democratic principles envisaging, in particular, the equal participation of all member-states in controlling all functions of this system, a just distribution of contributions by participants in this system and the complete exclusion of any discrimination whatsoever ". The system would be open to all states, and the proposal is not intended to exclude the existence of other space communications systems. " In-

tersputnik " would be managed by a special council whose members would be drawn from all the signatory states.

Oléiculture : Le Conseil oléicole international a décidé de demander au Programme des Nations Unies pour le Développement de l'aider à créer un centre international de démonstration et de développement dans le cadre du Programme FAO pour l'amélioration de la production oléicole dans le bassin méditerranéen. Le centre serait établi en Andalousie, au cœur de la principale région productrice d'olives de l'Espagne. Le Conseil a accepté une offre du gouvernement italien de créer à Bari un centre de spécialisation avancée dans les sciences de l'oléiculture. Les spécialistes de ces sciences pourront y approfondir leurs connaissances dans les questions de la recherche et de l'enseignement des techniques de l'oléiculture.

*The International Olive Oil Council hopes to establish an experimental centre in Andalusia to further production in the Mediterranean region.*

World aid : The past 20 year's experience in world aid and development are to be reviewed by an international commission headed by Mr Lester Pearson, former Prime Minister of Canada,

with the aim of deciding what was achieved, where the failures lay and what policies might be followed for the future. Members of the commission will be people " who have had experience with and shown capacity for understanding world problems and offering leadership in their solutions ". Mr Robert McNamara, at whose request the commission is to be set up, wants it to consider ways of providing aid over the next generation in order to ensure a reasonable hope of sustained, and eventually self-sustaining, growth in the less-developed countries. He also invites suggestions concerning the action which these less-developed countries need to take to facilitate their economic growth.

Voluntary service : The agenda of the recent Commonwealth Education Conference, held in Lagos, included a discussion of the feasibility of setting up a Commonwealth Scheme for Voluntary Service Overseas. Although it was realised that such a scheme would present great administrative difficulties, participants urged the Commonwealth Secretariat to seek ways of extending co-operation between Commonwealth countries. The developing countries particularly find a significant source of teacher supply volunteers.

African credit : In 1963 Abbe E. Kibirige introduced credit organizations to the teachers

of Uganda; now there are four societies officially registered and six others waiting for recognition. This is a particular illustration of the way the movement is developing in Africa in general, and the latest stage is the decision to create an All-African Credit Union Associa-

tion, which was taken in July at an international congress held at the Roma University in Lesotho.

#### Nouveau siège

Le Conseil a examiné et approuvé le programme des activités et le budget de l'Organisation internationale du travail pour 1969.



#### 52<sup>me</sup> session de la Conférence internationale du Travail

La 52<sup>me</sup>\* session de la Conférence internationale du Travail s'est tenue à Genève du 5 au 25 juin 1968.

#### Participation aux travaux de la Conférence

Sur les 118 pays Membres de l'O.I.T., 109 étaient représentés. Le nombre des délé-

gués et conseillers techniques s'est élevé au chiffre de 1.179, qui se décomposait ainsi :

- 215 délégués et 383 conseillers techniques gouvernementaux;
- 103 délégués et 173 conseillers techniques employeurs;
- 104 délégués et 201 conseillers techniques travailleurs.

Soixante-neuf ministres responsables des questions du travail ont assisté à la Conférence. Grenade, l'Île Maurice et le Saint-Siège étaient représentés par des observateurs. Les Nations Unies et 15 autres organisations intergouvernementales étaient représentées par 37 observateurs. Enfin, 30 organisations internationales non gouvernementales s'étaient fait représenter par 82 observateurs.

#### Principaux résultats de la session

- adoption d'une résolution concernant l'action future de l'O.I.T. dans le domaine des droits de l'homme ;
- adoption d'une recommandation internationale du travail sur l'amélioration des conditions de vie et de travail des fermiers, des métayers et des catégories analogues de travailleurs agricoles;
- adoption d'un avant-projet de convention et de recommandation sur l'inspection du travail dans l'agriculture;
- adoption d'un avant-projet de convention et de recommandation sur l'assurance-maladie (revision des conventions N°s 24 et 25 de 1927);
- adoption du budget de l'O.I.T. pour 1969;
- adoption de résolutions concernant la préparation professionnelle des jeunes filles et des femmes, l'exode de personnel qualifié des pays en voie de développement, les travailleurs à capacité diminuée et les activités de coopération technique l'O.I.T.;
- examen d'un rapport sur la manière dont les Etats Membres appliquent les normes de l'O.I.T. Les 15 ratifications enregistrées pendant la session de la Conférence ont porté à 3.371 le nombre total de ratifications apportées aux conventions de l'O.I.T. Avec la nouvelle recommandation adoptée au cours de cette session (sur les fermiers, métayers, etc.), le nombre total des conventions internationales du travail adoptées depuis 1919 est de 128 et celui des recommandations de 132.




#### NGO contributions


#### Budget

In 1965 the UAI introduced the system of indexing by date in connection with its "Bibliography of Proceedings of International Meetings held in 1959". The system was adopted from January 1966 onwards in the monthly "Bibliographical Current List of Papers, Reports and Proceedings of International Meetings".

Its practical advantages, particularly as regards speed of production, have led us to use it for the "International Congress Calendar" also. As the entries in the Calendar are in strict chronological order, any particular item can be found immediately from the date given after the appropriate keyword in the index starting on page 821.

This supplement gives details of new congresses announced after the annual Calendar (which appeared as the December 1967 issue of International Associations) closed for press. The insertion of "•" after the date indicates that previously published arrangements have been modified.
