#### Keynote: "In Today's New World (Dis)Order, do Associations Depend Too Much on Governments?"

"Associations in today's world are confronted, often on a daily basis, with unforeseen - frequently unforeseeable - financial/political/cultural/scientific challenges, not to say threats. Such actions by governments have caused some Associations to have already sunk beneath the level of survival.

The decisions that governments make, even where they are democracies that uphold the Rule of Law, too often minimize the actual and potential contributions of Associations to advancing world peace, to managing humanitarian action, to achieving gender equality and many other aspects of social justice. Governmental decisions often run counter to the terms of Conventions and other international instruments and declarations that the same governments have freely adopted and ratified.

How can Associations, which are autonomously constructed groupings of citizens with a vote in their home country, navigate "the power of the state" without being pushed into a dependency relationship? How can Associations uphold their ethical standards and their human values in situations where an authoritarian government traduces the rule of law, or where a self-assured government alters its financial agreements with Associations without consultation, often without warning."

## Workshop: "Why does the United Nations need Associations? Why do Associations need the United Nations?"

Under a variety of designations (NGOs, CSOs, Stakeholders, Third Sector, Partners and more) the UN System and the multi-facetted Association world have a long history of interaction, and in some case of interdependence.

The Workshop will explore the ups and downs of this relationship, looking at how words and deeds coincide or conflict, and considering where new realities are leading us."

Professor of History, Birkbeck, University of London

#### **Biography**

Jessica's main research interests lie in the social and political history of competing conceptions of internationalism; international organisations and networks; the history of international conferences; humanitarianism; migration and displacement; science and expertise; the world wars and post-war reconstruction.

She first joined Birkbeck in 2005 as a postdoctoral researcher, after completing her PhD at Imperial College London in the Centre for the History of Science, Technology and Medicine.

Her Perils of Peace: the Public Health Crisis in Occupied Germany (Oxford University Press, 2013) is an open access monograph.

### Dr. Margot Tudor

Lecturer in Foreign Affairs and Security, City - St George's, University of London

#### **Biography**

Dr. Margot Tudor is a Lecturer in Foreign Policy and Security in the Department of International Politics at City St George's, University of London. Her first book, Blue Helmet Bureaucrats: United Peacekeeping Missions and the Reinvention of Colonialism, 1945-1971, was published by Cambridge University Press in 2023. She is currently working on a new book project on the entanglement of peacekeeping identities and patriarchal values during the first UN mission.

#### Dr. Gordon Barrett

Research Fellow in History, Northumbria University

#### **Biography**

Gordon Barrett's research focuses on the politics of science, technology, and medicine in modern East Asia, with particular interest in the roles of non-state actors from transnational activist networks to international organisations. He is a Research Fellow in History at Northumbria University on the 'Global Governance, Trust and Democratic Engagement in Past and Present' project (Trans-Atlantic Platform) and is serving as Co-Secretary of the DHST Commission on Science, Technology and Diplomacy (STAND).

Together with Aya Homei, he has edited the special issue 'Decentring Histories of Science Diplomacy: Cases from Asia' (British Journal for the History of Science, 2024). He is the author of China's Cold War Science Diplomacy (Cambridge: Cambridge University Press, 2022), has solo-authored articles published in the BJHS, Journal of Cold War Studies, and Modern Asian Studies, and was one of the lead authors for an article on the globalisation of science diplomacy for Science and Public Policy.

### Prof. Daniel Laqua

Professor of Modern and Contemporary History, Northumbria University, UK

#### Biography

Prof. Daniel Laqua is Associate Professor at Northumbria University in Newcastle upon Tyne, UK.

He is the author of Activism across Borders since 1870: Causes, Campaigns and Conflicts in and beyond Europe (London, 2023) and The Age of Internationalism and Belgium, 1880-1930: Peace, Progress and Prestige (Manchester, 2013) as well as the (co-)editor of three books and six special issues of academic journals.

He has published widely on the history of international movements and organisations, including a volume on the history of UIA, International Organizations and Global Civil Society: Histories of the Union of International Associations (London, 2019).

He is currently leading a large international project on 'Global Governance, Trust and Democratic Engagement in Past and Present' (funded via the Trans-Atlantic Platform for the Social Sciences and Humanities) and is serving as co-lead of a research network entitled 'Rethinking Internationalism: Histories and Pluralities'.

## Workshop: "From Problem to Progress: Conflict as Creativity for International Organisations"

The attempt to combine international ambitions with local action can generate tensions and misunderstandings. This workshop explores several examples, drawn from the cases of various activist groups that had a global vision. It will consider how such conflicts do not necessarily need to be seen as 'problems', highlighting how they could also generate innovative practice. The workshop is delivered in collaboration with an international project on 'Global Governance, Trust and Democratic Engagement in Past and Present'.

Workshop: "VAT and Related Issues Concerning International Associations"

VAT is a constant source of concern for international associations in their daily activities and especially when they are organizing conferences in their own country or another. Philippe Noirhomme will discuss the information needed to clarify the situation regarding this tax and its application.



A special focus will be given to webinars and virtual educational activities due to the new EU regulation, which has been applicable since January 1, 2025.

#### Biography

Philippe Noirhomme is a certified tax adviser working with Ryan Tax Consulting. He previously spent 11 years with Ernst & Young Tax Consultants in the Indirect Tax department, and is currently a Lecturer at the Tax Institute of the University of Liège and Teacher at Solvay Brussels School (Executive Master in International Association Management). He is co-author of "VAT Package: the new rules applicable to services", published by Editions Larcier in January 2010.

Workshop: "Achieving goals, finding partners: UIA's Global Civil Society Database"

UIA provides tools and data to help associations with their outreach, event planning and more. Ryan will present a number of UIA's tools, including a live demo of 'Open Yearbook' and 'Open Calendar', explain the history and future plans of the Global Civil Society Database, and will answer questions about how associations can best take advantage of these free resources.



#### **Biography**

Ryan has worked as a web and database developer at UIA since 2011. He is responsible for the user interface of UIA's databases, the ongoing development of UIA's website and the visual identity of the organization. He also provides regular training sessions on the use of UIA's Yearbook of International Organizations and International Congress Calendar digital publications.

Before joining UIA, Ryan ran a communications design studio crafting online identities for associations and small businesses.

#### About the UIA

"... to serve as a centre for documentation, study, service, and the promotion of closer relations between international associations."

The Union of International Associations (UIA) is a non-profit, independent research institute documenting the current and historical work of international nongovernmental organizations (INGOs) and intergovernmental organizations (IGOs) and promoting the public awareness of their activities.

Since its foundation, the UIA has focused on recording the nature and evolution of international civil society. The UIA's focus today is on promoting the internationality of these organizations and in representing the collective views of international bodies.

The UIA collects, hosts and provides up-to-date, reliable information on global civil society, and maintains the most comprehensive source of information on international associations, their activities and concerns, and their meetings activities.

The UIA has existed since 1907 when it was founded by two Belgians, Henri La Fontaine and Paul Otlet. La Fontaine was an international lawyer, professor of international law, and a member of the Belgian Senate for 36 years. He was a socialist, a renowned bibliographer, and a devoted internationalist. In 1913 he was awarded the Nobel Peace Prize for his work as "the effective leader of the peace movement in Europe". He and his sister Léonie La Fontaine were also early advocates for women's rights and suffrage, founding the Belgian League for the Rights of Women in 1890.

Otlet was a lawyer, bibliographer, political activist, and a Utopian with an internationalist agenda. His seminal work in documentation included the

creation of the Universal Decimal Classification system. Otlet envisioned an international Network for Universal Documentation: a machine which would allow users to search, read and write to a database stored on millions of index cards, and which could be accessed from great distances. The idea of networked documents was so novel that no one had a word to describe these relationships until Otlet invented one: links. Today, Otlet is considered one of the fathers of information science.

The UIA has Consultative Relations with UNESCO, UN/ECOSOC, and ILO. It collaborates with the Council of Europe and the European Commission.

#### **UlA's Purpose**

The UIA's aims as stated in its statutes are to:

- To undertake and promote research and studies on transnational associative networks, considered to be an essential component of contemporary society
- To collect and distribute the most comprehensive documentation possible on international organizations and associations, both governmental and non-governmental, and on new forms of transnational co-operation
- To collect and distribute data on the various meetings organized by international bodies
- To encourage and undertake all possible action aimed at promoting the development and efficiency of non-governmental networks, as well as communication between people working in an international context and co-operation between associations
- To study, categorize, analyse, compare and illustrate world problems as perceived by international organizations.

The UIA seeks to achieve these goals primarily in three ways:

#### 1. By documenting global civil society activity

The UIA's associations database – the basis of the Yearbook of International Organizations both online and in print – attempts to cover all "international organizations", according to a broad range of criteria. It therefore includes many bodies that may be perceived as not being fully international, or as not being organizations as such, or as not being of sufficient significance to merit inclusion. Such bodies are nevertheless included, so as to enable users to make their own evaluation in the light of their own criteria.

In preparing and updating the organization profiles, the UIA gives priority to information received from the organizations themselves, then checks this information against other sources (periodicals, official documents, media, etc.) to present a reliable picture of a dynamic situation. The information presented by the UIA is structured, comprehensive and concise. A standard framework makes comparison possible.

#### 2. By publishing research reports

The UIA's associations database is continuously updated and includes descriptions of some 70,000 international organizations – NGOs and IGOs – active in all fields of human endeavour, in all corners of the world, and throughout centuries of history.

Its meetings database - the basis of the International Congress Calendar both online and in print - currently includes over half a million international meetings of these bodies, from 1850 to far into the future.

The organization profiles and meetings profiles are complemented by bibliographies, SDGs, statistical reports, and descriptions of problems perceived and strategies adopted by international associations as well as the values and approaches that animate them. Over 500,000 hyperlinks facilitate navigation through this data.

The UIA also produces customized reports on demand for a variety of governmental, non-governmental, and commercial bodies.

3. By providing training and networking opportunities for international association staff

Since 2007 the UIA hosts annual Associations Round Tables, bringing together representatives of international associations to learn practical skills and share experience.

On 19 & 20 November 2026 the 20th UIA Associations Round Table Europe 2026 will be held in Lucerne, Switzerland.
