The tables give the number of international meetings held each year in the major countries of each continent during the last five-year period 2002-2006. Country totals are expressed as a percentage of the continent total; continent totals are expressed as a percentage of the world. Meetings taken into consideration include (a) those organized and/or sponsored by international organizations, and (b) some national meetings with international participation (provided they have a minimum of 300 participants, at least 40% foreign, at least 5 nationalities, and of at least 3 days duration). Excluded are meetings taking the form of religious gatherings, courses, party conferences, fairs, sales meetings, as well as closed administrative and expert meetings.
