### Participation in international organizations by continent and cluster: 2008

These tables provide an overview of participation, through membership, of different continents in different clusters\* of international organizations (as introduced in Figure 0.1). The summary is by continent and cluster, also showing percentages of intergovernmental organizations (IGOs) and nongovernmental organizations (NGOs).

For example, there are 6,047 African members of IGOs in Cluster I; American members comprise 18 % of all members of Cluster II organizations. Refer to Figures 0.2.2 – 0.2.4 for more detailed breakdowns by organization types with each cluster. See Figure 2.1.1. for more detail on participation. For information on organization types in the *Yearbook of International Organizations* see Appendix "Types of organization".
