This table lists the countries with at least 20 meetings of type A during the period 2007 to 2011, giving the total number of meetings of type A in each country per year from 2007 to 2011. Countries are listed in alphabetical order.

**Meetings counted under the heading "A" are "Meetings of international organizations" and meet all the following criteria:**

- meetings organized or sponsored by "international organizations", i.e. international non-governmental organizations (INGOs) and intergovernmental organizations (IGOs) that are included in the UIA's *Yearbook of International Organizations* (see the Introduction "What is an 'international organization'") and whose details are subject to systematic collection and updates on an annual basis by the UIA
- with at least 50 participants, or number of participants unknown.

The total meetings of all countries for each year of type A is used to calculate the percentages.

**Caveat:** When comparing consecutive years in flux, it should be remembered that both years' totals can be expected to change over time, the latest slightly more rapidly than the older. The number of meetings for the current reporting year (2011) is expected to be around 80 percent of that extracted from the database three to five years, by which time data stability is expected to be more or less reached for 2011.

- meetings not organized or sponsored by "international organizations" but nonetheless of significant international character, notably those organized by national organizations and national branches of international organizations
- at least 40 percent of the participants are from countries other than the host country and at least 5 nationalities are represented
- lasting at least 3 days, or of unknown duration
- with either a concurrent exhibition or at least 300 participants

This table lists the countries with at least 20 meetings of type A+C during the period 2007 to 2011, giving the total number of meetings of type A+C in each country per year from 2007 to 2011. Countries are listed in alphabetical order.

#### Meetings counted under the heading "C" are "Other international meetings (2 days)" meet all the following criteria:

- meetings not organized or sponsored by "international organizations" but nonetheless of significant international character, notably those organized by national organizations and national branches of international organizations
- at least 40 percent of the participants are from countries other than the host country and at least 5 nationalities are represented
- lasting at least 2 days, or of unknown duration
- with either a concurrent exhibition or at least 250 participants

The total meetings of all countries for each year of type A+C is used to calculate the percentages.

**Caveat:** When comparing consecutive years in flux, it should be remembered that both years' totals can be expected to change over time, the latest slightly more rapidly than the older. The number of meetings for the current reporting year (2011) is expected to be around 80 percent of that extracted from the database three to five years, by which time data stability is expected to be more or less reached for 2011.
